



“Americans With Disabilities Act” Workshop

Description – The Americans with Disabilities Act of 1990 (ADA) prohibits discrimination based upon disability. Title III of the act focuses on public accommodations and states that “barriers to access” are considered discrimination. Also under the ADA, all new construction must meet the requirements of the Americans with Disabilities Act Accessibility Guidelines, which are part of the Code of Federal Regulations. This course is designed to provide you with the **basic principles and core concepts of the Americans with Disabilities Act of 1990 (ADA)**. Upon completion of this course, you will be able to: (a). Discuss the purpose of the ADA using a civil rights framework; (b). Identify the five titles of the ADA; (c). Define the general nondiscrimination requirements of the ADA; (d). Locate and use various resources for information on the ADA.
